Wally's Pub Canandaigua USBC Masters Tournament Classified Division Rules

1. **Eligibility:** Only current members of the Canandaigua, Rochester, Finger Lakes, Genesee Region, Lake Ontario, and Auburn USBCs (men, women) with a minimum of 9 games in ANY OF the CURRENT or prior 3 bowling (2021-22, 2022-23, 2023-24, 2024-2025) seasons within one league will be allowed to bowl in this tournament. Bowlers will be required to show their USBC certification card. This tournament is NOT SMART certified.
2. **Entry Rules:** Prepaid entries received by 3/20/25- \$60. Entries received after 3/20/25 - \$80. Entries may be turned into Roseland Bowl front desk, email to mdb080489@gmail.com. *Entry fees may be paid by credit card at Roseland Bowl front desk. Fees must be received by the early bird deadline. Call Roseland at 585-394-5050 to pay by card.*
3. **The number of entries will determine the number of bowlers who advance after qualifying:**
Less than 20 entries: Top three will advance into stepladder match play finals
21-30 entries: Top four will advance into match play finals (1 vs 4, 2 vs 3, winners advance to championship match)
31-47 entries: Top six will advance into match play finals (Top 2 seeds will receive one round byes)
48 or more entries: Top eight will advance into match play finals (1 vs 8, 2 vs 7, etc. winners advance until a champion is declared)
4. **Qualifying Format:** A (4) four game qualifying event will take place on Sunday, March 23, 2025 with total pin fall determining the who will advance into the match play finals. Starting lanes will be assigned at check-in. A maximum of six bowlers allowed on a pair of lanes. Participants will move lanes after each game. A tie for the final qualifying spot will result in an immediate one game roll-off. Ten minutes of practice will be allowed prior to competition.
5. **Match Play Format:** Match play will vary depending on entries; see rule 3 for initial advancement. If only three bowlers advance a stepladder format will be used with #3 and #2 matched up, with the winner advancing to the championship against the #1 seed. If more than three bowlers advance to match play all matches will be bracketed and seeded according to qualifying scores. The champion will receive a plaque. The champion may also apply the cost of the plaque toward a champions ring. The bowler will pay the cost difference.
6. **Dress Code:** Acceptable attire: Collared or bowling ball company shirts, long pants (dress or like-new blue jeans), dress shorts and skirts. The following is not allowed during tournament competition: Hats, t-shirts, short shorts, mini-skirts, cut off blue jean shorts, tank tops, clothing that are dirty or has holes in them, or shirts not covering the belly button. Violations will be determined at the tournament director(s) discretion.
7. **Classified Division,** in order to enter, bowlers **must have an average of 199 or less**, based on the highest of the previous season for 21 games or the current season for 21 games as of 3/16/25. Averages must be verified. Current averages as of 3/16/25 shall be documented with a league standing sheet. Sport averages will be adjusted according to the USBC Average Conversion Chart. Anyone recording an incorrect average will be automatically disqualified per USBC rule 319a, item 3. If a bowler cashed in the previous season's Master's Open Division they may not enter the classified division.
8. **Rules:** All USBC Rules not included here will be in effect. The Tournament Director will resolve all disputes, subject to rule 329.
9. **Prizes and Awards:** First place cash value will be \$500 based on 32 entries. All prize fees collected will be returned 100% to participants.
10. **Entry Fee Distribution:** Entry fees for this tournament are distributed as follows, Prize Fee: \$39.00, Bowling Expense: \$18.00, Tournament Expense: \$3.00. Total Entry Fee: \$60.00. Walk in entries will be assessed an additional \$20 fee going directly to the prize fund
11. **Check-In Procedures:** All entrants are to report for check-in 30 minutes prior to squad time. Tournament staff will close walk-ins 15 minutes prior to squad time
12. **Re-Rack:** A maximum of two re-racks per game allowed. Any further re-racks require permission from tournament official.
13. **Premature Termination:** Premature termination of the tournament brought about by war, national emergency or emergency causes relating to or from, fire, natural disaster or any other reason beyond the control of the tournament shall cause prizes to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
14. **Bowling Balls:** Only USBC approved bowling balls are allowed. Plugged balls are allowed. Balls must meet USBC weighting specifications. Tournament Director Reserves the right to check any bowling ball used. Illegal balls will result in the bowler's disqualification.
15. **Brackets:** Brackets will be available and run for the courtesy of the bowler and the organization assumes no responsibility for losses or any inaccuracies.
16. **REFUNDS:** No entry fees will be refunded. Replacements will be permitted from waiting list, subject to prior arrangement with tournament management. **All returned checks will be assessed a \$30.00 fee.**
17. **LANE COURTESY:** Lane courtesy rule is two lane courtesy.
